

I. Product Description

This product is prepared from fresh chili peppers that are dehydrated, milled to desired particle size, and blended with spices, and garlic to achieve desired pungency, caramelized color, and flavor. No more than 2% silicon dioxide added as a flow agent. Ethoxyquin is added to retard color loss.

The aroma and flavor is mild to moderately pungent rich chili powder with garlic, earthen, and caramelized notes. The appearance is a dark red to brownish red, free-flowing powder.

Treatment: Product is not treated, but may contain components treated with steam or ethylene oxide.

Chili Peppers, Spices, Salt, Garlic Powder, Silicon Dioxide, Ethoxyquin <100 ppm

Olam ingredients are grown or purchased from non-GM sources and can be considered non-GM, however no further tracking or testing is conducted. In all cases, food safety and quality are the main criteria of concern.
